<u>PRESS RELEASE</u> Caring for the Environment, Moratelindo Plants Mangrove Seedlings

Jakarta July 26th, 2018 - PT Mora Telematika Indonesia (Moratelindo) with the issuer code "MORA" which is a telecommunications infrastructure provider company is committed to supporting and preserving the environment through the implementation of one of its Corporate Social Responsibility (CSR) programs. In the framework of the International Day for Mangrove Ecosystem Conservation which coincides on this day July 26th, 2018, Moratelindo realizes its CSR commitment in environmental preservation by again carrying out mangrove seedling planting activities as many as 1,000 mangrove seedlings planted in the Marunda Coastal area, Cilincing, North Jakarta. Similar activities have previously been carried out by Moratelindo in 2015 by planting as many as 1,200 mangrove seedlings in the Marunda coastal area.

The activity was attended by the Board of Directors and Moratelindo employees as one form of CSR program implementation, namely mangrove seedling planting, which is the result of collaboration between Moratelindo and the Indonesian Mangrove Restoration Foundation. The activity is planned to be carried out by Moratelindo on an ongoing basis as a form of Moratelindo's commitment and attention to the environment, especially to the sustainability of mangrove forests to prevent abrasion and maintain the ecosystem of coastal areas that are needed for now and in the future.

Moratelindo at a glance

Moratelindo is a wholesale telecommunications infrastructure provider established in 2000. Moratelindo opened an international office in Singapore along with the construction of the MIC-1 (Moratelindo International Cable-system One) submarine cable connecting Jakarta-Singapore. The Singapore government granted a Facilities-Based Operations (FBO) license to Moratel International Pte. Ltd., as a network gateway for international leased line services.

In the span of 2010 to 2012, Moratelindo has completed the construction of an international submarine backbone network for Jakarta, Bangka, Bintan, Batam and Singapore (B3JS) for more than 1,000 km and an international submarine backbone network for Batam-Dumai-Malaka (BDM) for more than 400 km which is the result of collaboration between Moratelindo, XL Axiata and Telekom Malaysia.

The success of Moratelindo's performance continues, where in 2016 and 2017 Moratelindo has been given the trust of the Government of the Republic of Indonesia through the Ministry of Communication and Information Technology of the Republic of Indonesia to carry out one of the National Strategic Projects, namely the West and East Palapa Ring Package Projects, by forming an Implementing Business Entity namely PT. Palapa Ring Barat and PT. Palapa Timur Telematics. The Palapa Ring project is a Public Private Partnership (PPP) project in the telecommunications sector with an availability payment (AP) scheme. The AP scheme was initiated by the Ministry of Finance with AP guarantees carried out by PT Penjamin Infrastruktur Indonesia (Persero) and the source of payment comes from the Universal Service Obligation (USO) Contribution Fund. In implementing the Palapa Ring project, funding for the

West Package came from Bank Mandiri amounting to Rp 876 billion and for the East Package came from a syndicated loan from Bank BNI, Bank ICBC Indonesia, BPD Papua, BPD Sulselbar, BPD Maluku Malut and others amounting to Rp 4 trillion.

For the success of Moratelindo's performance, on December 7, 2017 Moratelindo has succeeded in conducting the initial bond offering of Bonds I MORATELINDO Year 2017 on the Indonesia Stock Exchange in Jakarta with a value of Rp. 1,000,000. 000, - (one trillion Rupiah) which has received an idA (Single A) rating from PT Pemeringkat Efek Indonesia, where during the Initial Offering Period (Bookbuilding), received a positive response from investors as shown by oversubscribed up to around 1.4X from the target of Rp. 1,000,000,000, - (one trillion Rupiah).
